ACCOMMODATIONS: A block of 30 rooms has been reserved for both Friday Nov. 3 and Sat. Nov. 4. at the Adams Mark Hotel, 120 Church Street, Buffalo. Rates are: single-\$75, double-\$87, triple-\$99, quad-\$111 per night. Rates are subject to state and local taxes, currently 13%. For reservations, call 1-800-444-2326 and ask for the NYSCU rate. Rooms will be held until Oct. 4, 2000. Check-in is at 3pm, check-out is at 12 noon.

There is a \$5.75 per night parking fee with in and out privileges. There is a in/out baggage handling fee of \$3.50 per person. Luggage carts are not for private use; they have bellmen (and women - we hope).


## 3. COVENANTING WITH THE PAST, PRESENT AND FUTURE:


The Murray Grove Association
John Murray preached his first sermon in America exactly 230 years ago on September 30 in Thomas Potter's chapel at what is now called Murray Grove. For over 100 years, the Murray Grove Association (MGA) has held these tender beginnings of the Universalist denomination in America as its most precious treasure. Come join Ellen Chulak, MGA Executive Director, to talk about how MGA's distinct history is begin shared today and how it has inspired a new and exciting future that will honor its heritage while serving our UU denomination in vital and innovative ways.

#### 4. BUILDING DREAMS WORKSHOP

We will go through the "process" of church construction: feasibility study, how to choose a builder and/or an architect, and what to expect during construction. Bring coffee and be prepared to speak candidly about the simple, but not easy, process of building or rebuilding our community.

The Rev. Wayne Walder, in a previous career, was president of an award-winning building corporation for more than 20 years. He chaired Toronto First's rebuilding committee when that church was gutted and rebuilt. He is Minister for the new-start "Neighbourhood Congregation" in the East end of Toronto. He hopes that his services will be called upon to start another building project there.





UUCB is located in north-central Buffalo at 695 Elmwood Ave. at the intersection with West Ferry St.

#### DIRECTIONS:

AIR: Buffalo Niagara International Airport is located outside the city just off Route 33. Airlines include American, Continental, Delta, JetBlue, Northwest, Shuttle America, USAir, United.

The Adams Mark hotel provides a complimentary shuttle service to and from the airport between 6 a.m. - 10:30 p.m.

**BUS:** Greyhound and Trailways provide service to Buffalo. The station is about 1 mile from the hotel and about 3 miles from the church. Taxi fare to hotel is \$3.

CAR: Directions to the Church: NY Thruway (I-90) to Rt. 33 west, to Rt. 198 west, to Elmwood Ave. South exit. The church is about 1 mile south on the left. You'll find street parking within a block of the church, nearby on Elmwood or West Ferry. Alternatively, you can park in the lot behind M&T Bank on Elmwood next door to the church. On-street handicapped parking spaces can be found at the West Ferry entrance. The church does not have its own parking lot.

Directions to Hotel: Route 33 west to the end of highway, becomes Oak St., take right onto North Division St., take left onto Church St. Hotel is on the left.

**RAIL:** Amtrack station in downtown Buffalo. Taxi fare to hotel is \$5 - \$8.

#### 5. WEB WORKSHOP:

Effective Electronic Communications for your Congregation/ Organization
Get your congregation on the web and include effective content for visitors and members. The elements of an effective web site and synergy with other types of electronic communication will be reviewed. In an interactive Q&A and brainstorming session, we will share what has and hasn't worked for our unique situations. An introduction to basic HTML will be included, if there is time.

Tom Upshaw, Electronic Communications Administrator for the UU District of Metro New York, maintains the District web site and mailing lists, as well as those for his congregation. He also helps maintain the UUA announcement mailing list (UUA-L) and several web sites and mailing lists related to genealogy. Originally from Tulsa, OK, Tom received a Ph.D. in organic polymer chemistry from Colorado State Univ. Just after discovering Unitarian Universalism, he joined the Unitarian Society of New Brunswick, NJ in 1990, where he has been a member ever since, serving on the Board and various committees, including two years as President.
