For a shuttle from the railroad station, telephone with the train you will arrive on.

From points north or south using the NYS Thruway

NYS Thruway to New Paltz Exit. Take Route 299 East to Route 9W. Take Route 9W south to exit for Mid Hudson Bridge, crossing the Hudson River (\$1 toll) on Route 44/55 East. Continue on Route 44/55 East (also known as Church Street and Baker Street) to South Cherry Street (seven lights). Turn right onto South Cherry Street. At the second light, turn left onto Hooker Avenue. Turn right onto South Randolph Avenue. Turn left into the UUFP's parking lot at 67 South Randolph Avenue.

From points north or south using Route 9

From Route 9, turn onto Sharon Drive (there's a Holiday Inn Express on the corner). Follow Sharon Drive to its end. Turn left at the stop sign onto Beechwood Avenue. Turn right at the next stop sign onto Ferris Lane. Make your first left onto South Randolph Avenue. The Fellowship is the second driveway on the right.

From points north or south using the Taconic State Parkway

Taconic State Parkway to exit for Route 55 (West). Follow Route 55 West, which merges with Route 44 West. Stay in left lane. Turn left onto North Grand Avenue, which becomes South Grand Avenue. From South Grand Avenue, turn right on

Hooker Avenue. Turn left on South Randolph Avenue. Turn left into the UUFP's parking lot at 67 South Randolph Avenue.
