On motion elected Edmund Badger to preside at this meeting as Moderator. Elected Reuben Mills clerk to this meeting. Resolved, that this society forever hereafter be known and distinguished by the name and title of "the first Universalist Society in the Town of Alden" as aforesaid. Resolved, that three Trustees be elected to this Society. The following persons were duly elected as said Trustees: viz. Ira Gage, Cyrus Litchfield, Morris Cady[.] [T]he said trustees were then duly classed No. 1, 2, 3, and drawn according to statute. Trustees belonging to class No. 1 Ira Gage—and No. 2 Cyrus Litchfield and No. 3 Morris Cady. On motion, elected Reuben Bills Clerk of said society and also clerk of said Trustees. Resolved, that Edmund Badger and Reuben Bills be the returning officers, to make and file the certificate with the county clerk. Resolved, that this meeting adjourn sin die.
