# Prelude and Articles of Compact of the First Universalist Society in the Town of Oswegatchie

#### Preamble

Being impressed with a deep sense of our obligations of love, gratitude and obedience to that indivisible eternal almighty Being from whom all existence emanated and every blessing is derived[,] who superintends the affairs of the Universe and extends his never failing mercies unto all creatures, being aware of the social capacities, mutual dependence and reciprocal obligations of the human family as the children of one common Parent; Being sensible of the importance of the peace and peaceful religion of Jesus Christ who is the image of the invisible God, the first born of every creature, we therefore whose names are hereunto annexed agree to unite ourselves into an association for the support and enjoyment of public worship according to the dictates of our conscience.

### Articles of Compact

- Art. 1 This Society shall be denominated the First Universalist Society in the town of Oswegatchie.
- Art. 2 The object of this society shall be the cultivation of peace and harmony and the promotion of religion and morality among ourselves and our fellowmen.
- Art. 3 The officers of this society shall consist of five trustees and a clerk to be chosen annually from among the members of this society. It shall be the duty of the trustees to transact all the temporal business of the society[,] take charge of all property belonging to the same, keep a true record of their proceedings and make report of the same to the society at each annual meeting. It shall be the duty of the clerk to keep a faithful record of all proceedings of the society and trustees that are necessary to be recorded and transmit them to his successors in office.
- Art. 4 The society shall meet annually for the choice of officers and the transaction of business on the first Wednesday in January in the village of Heuvelton. The election of each officer shall be by a majority of the votes of the members present. Special meetings may be held at any time for the purpose of filling vacancies in office or the transaction of other business when a majority of the trustees may deem it necessary.
- Art. 5 Any person sustaining a good moral character uniting in the object of this society, wishing to promote the interest of pure religion and uncorrupted christianity and desirous of becoming a member of this society may become such at the discretion of one or more of the trustees and by signing his name to this constitution.
- Art. 6 Any member of this society may at any time withdraw from the same by giving notice to the clerk or either of the trustees, and may receive a certificate expressive of his or her character and no member shall be excluded from this society without a fair trial, after being furnished with a copy of the charges, and the name or names of his or her accusers and by a vote of two thirds of all the numbers present at a meeting called for that purpose.
- Art. 7 Any alterations or amendments may hereafter be made in this constitution at any annual meeting of the society provided that two thirds of all members present concur in such alteration or amendment.
